Over the next seven days, we will dive deeply into this passage, examining the cultural and spiritual context, the significance of Jesus' words, and the lessons we can apply in our walk of faith today.

As we study, keep an open heart to what the Holy Spirit teaches about honoring God and earthly governments, discerning Jesus' identity, and trusting in His provision. Let this story transform how you view your role as a citizen of God's kingdom and the world around you.

#### Your Verse

Matthew 17:24–26 NIV – "After Jesus and his disciples arrived in Capernaum, the collectors of the two-drachma temple tax came to Peter and asked, 'Doesn't your teacher pay the temple tax?"

- Exodus 30:13 'You will collect the atonement money from the Israelites and give it to the Lord as a ransom for your lives.'
- 2 Chronicles 24:8 'Every year, King Joash gave the priests seventy-five pounds of silver for the temple of the Lord.'

# Devotional: Understanding the Context and Cultural Expectation

To fully grasp this story, we first need to understand the setting and significance of the temple tax. The Jewish temple tax was an annual half-shekel payment required of all Jewish males to support the temple's maintenance and religious activities. This tax was deeply ingrained in Jewish culture and religious practice, echoing back to God's instruction through Moses as recorded in *Exodus 30:13*.

When the temple tax collectors ask Peter whether Jesus pays this tax, it raises a poignant question: how does Jesus, the Messiah and son of God, relate to this human institution? Is He subject to it? The question hints at tension between Jesus' heavenly identity and earthly obligations.

Reflecting on this cultural backdrop helps us appreciate the challenges Jesus and His followers faced and prepares us to understand what He does next in the story.

#### Your Verse

Matthew 17:27 NIV - "...go to the lake and throw out your line. Take the first fish you catch; open its mouth, and you will find a four-drachma coin. Take it and give it to them for my tax and yours."

#### **Supporting Scriptures**

- Exodus 9:3 'Behold, the hand of the Lord will come upon your livestock in the field, upon the horses, the donkeys, the camels, the cattle, and sheep.'
- Jonah 1:17 'Now the Lord had prepared a great fish to swallow up Jonah.'







Day 2: 🏟 The Miracle: The Coin in the Fish's Mouth

#### Devotional: God's Providential Care Displayed

Jesus' instruction to Peter to catch a fish and find a coin inside is a beautiful depiction of God's providence. While this miracle is subtle compared to others, it displays God's control over creation and His ability to provide for needs in unexpected ways.

In the Old Testament, God's sovereign hand is shown over livestock and nature, such as in *Exodus 9:3*, and He uses a great fish to deliver Jonah. Here, Jesus uses a similar motif to fulfill a worldly obligation, demonstrating that all things—including nature—are under God's authority.

This teaches us to trust God in daily provisions and to recognize His sovereignty over every aspect of our lives, even in small, practical matters.

Day 3: " Jesus' Identity Revealed

#### Devotional: Jesus Balances Divinity and Humility

Jesus' response reveals a profound understanding of His identity and mission. He acknowledges His divine sonship and yet chooses to pay the temple tax to avoid unnecessary offense.

This demonstrates His humility—though fully God, He submits to earthly customs to maintain peace and witnesses. *Jesus models a nuanced balance of divine authority and servant humility.* 

His words hint at the greater mystery of His unity with the Father (John 10:30) and His role as Creator of all things (Colossians 1:16). This passage invites us to contemplate the dual nature of Christ: fully God, fully man, walking gently with His people.

Day 4: 🐧 Paying Taxes with Purpose

#### Devotional: Respecting Earthly Authorities Faithfully

Jesus teaches a principle about civic responsibility: respect obligations to earthly governments. While His kingdom is not of this world, He does not dismiss earthly laws and structures, including the temple tax or governmental taxes.

Paying taxes is seen as an act of respect and submission to authorities, who are appointed by God for order and justice. Apostles like Paul and Peter affirm this teaching, encouraging believers to honor those in authority as part of their faith walk.

For us today, this means faithfully fulfilling civic duties without compromising our allegiance to God's higher authority. Jesus models how to engage in society with integrity, balancing kingdom living with responsible citizenship.

Paul encourages believers that God supplies all needs, and Jesus teaches not to worry about material things but focus first on God's kingdom. The God who cares for nature and orchestrates miracles promises to provide for His children.

When faced with financial pressures or uncertainties, remember Jesus' example and the biblical call to trust God fully. Such trust nurtures peace and frees us to serve Him with joyful hearts.
