Psalm 37:5 encourages committing your ways to the Lord, trusting in Him rather than lashing out or seeking illicit revenge. 2 Corinthians 9:6 speaks to the generosity of our sowing—when you consistently live by the Spirit, your life reflects God’s kingdom, even in adversity.

Today, consider what seeds your current struggles and responses are planting. Are you planting patience, dignity, prayer, and grace? Trust God to nurture these seeds and to bring about fruitfulness even through injustice.
